STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:	

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On November 18, 2017 at about 1:05 a.m. Northfield Police were dispatched to Viking Terrace just south of Fremouw Avenue in Northfield for a report of a motor vehicle accident involving a car which had crashed into three parked vehicles. Dispatch reported to the responding officers that the driver of the vehicle which had hit the other vehicles, Nick Craig Lino, (12/3/1995) was walking away from the vehicle. Officers found Lino near the vehicle, and asked if he was driving, he said he did not want to answer that question.

The vehicle which caused the damage was a Chrysler 300 MINN WZ3116 which registered to Lino and which officers recognized from prior contacts with Lino. Officer Kohn noticed a strong odor of alcohol coming from Lino. Officer Kohn performed HGN and noticed a lack of smooth pursuit and Nystagmus prior to 45 degrees. Officer Kohn asked Lino to take a breathalyzer, Lino refused. Officers sought and obtained a warrant for Lino's blood, the warrant was executed at Northfield Hospital.

In Lino's car was a passenger, ML. ML was seated in the left rear seat and was unable to get out of the car. ML complained of difficulty breathing, numb lips, and fingers along with back and rib pain. ACF reported he was in the front passenger seat at the time of the crash and that he was suffering from rib pain as well. ACF stated Lino was the driver of the vehicle and said "yeah, he's drunk." According to ACF, Lino had 10-15 shots prior to the crash and was driving 140-160 miles per hour traveling south on Dresden. Lino then crashed into the parked vehicles after blowing through the stop sign at Dresden and Fremouw.

Officer Feldhake found an open bottle of Durango Tequila under the driver's seat. Lino was previously convicted of DWI in Court File No. 66-CR-17-149 after a guilty plea on May 31, 2017.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
