Northfield has been a wonderful destination for us as a family, and it has exceeded my expectations for small-town living. With my five-year old daughter by my side, I have enjoyed summer concerts in the park, DJJD festivities, and Winter Walk events. This community pride and commitment to regularly gathering people from all walks of life is consistent with my values.

I grew up in Chanhassen, MN (another special small town in MN - though it was more rural back when I was a child). I attended Chaska High School and developed an early appreciation for foreign travel with a senior spring-break trip to Paris with my French class. I attended U of MN, Morris, majoring in French and a self-designed major related to international development. I was very active in student activities, gaining an appreciation for leadership and active community engagement. After college (and an extended time abroad researching community development in Senegal, West Africa), I worked at the U of MN, Twin Cities in campus activities, being awarded one of the prestigious Employee of the Year for my service there. I received my Master's in Public Policy from the Humphrey Institute, where I gained the tools and perspectives of how to both plan for and implement excellent public policy in service to communities all around the world.

Upon graduation, I launched my federal career as a Presidential Management Fellow with the Department of Justice, where I concentrated on international immigration policy, such as asylum and refugee decisions, and humanitarian parole. I then became a diplomat for the State Department. As a foreign service officer, I served in Mexico City, and represented the U.S. in United Nations negotiations in New York and Geneva. I was also a financial economist focused on improving international development policy and outcomes, especially within the World Bank and other multilateral development banks. I reviewed community development plans at the local, state, and national level and considered the impacts (environmental, social, financial) and made recommendations about what was in the best interest of the U.S. While at State, I volunteered as an EEO officer, received significant training in leadership and development, received awards for my service, and gave back by mentoring new professionals.

I have served as Carleton College's Program Director for Internships and Experiential Learning since 2015. In this role, I advise students on how to create experiential

changing climate.

I am a registered nurse and certified research coordinator. I am currently completing a master's degree in applied anthropology. This program is teaching me how to do applied research to understand and solve local current issues in a short time frame.

Since the summer of 2016, I have been working with several local groups to understand how Northfield residents engage with climate change and to help my community understand and act on climate change.

I worked with the Northfield Energy Working Group (a sub commission of Northfield's Environmental Quality Commission). With this group I helped to complete a study summarizing best practice climate action plans of other cities--plans that are actually already achieving greenhouse gas reduction and adaptation goals. The EQC presented the above study findings along with other climate action planning background information to the city council to encourage climate action planning to be included as a strategic goal.

I worked with the Greater Northfield
Sustainability Collaborative, and the
Northfield Area Community Solar groups to
collect over 900 Northfield resident
signatures to let our city council know
Northfield residents want renewable energy
in the future. With these groups, I also
participated in several events to educate the
public about climate change and to sell solar
garden subscriptions.

In January 2017, the Greater Northfield Sustainability Collaborative (GNSC) agreed to oversee my applied research project, so I could complete degree requirements. For the GNSC, I interviewed 30 Northfield residents asking the question, "How are you experiencing climate change?" The information from the applied research project will help to structure future climate change public participation activities.

Working with these groups has taught me that multi-level collaboration and action is needed NOW to lessen the local and global inevitable impacts of a changing climate. My knowledge of climate action planning and my applied research skills would bring a helpful perspective to either the Planning Commission/Zoning Board or the Environmental Quality Commission.
