The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Kidnapping-Confine/Remove Any Person-No Consent

Minnesota Statute: 609.25.1

Maximum Sentence: 20 years or \$35,000 fine, or both If safe-no GBH

Offense Level: Felony

Offense Date (on or about): 12/31/2017

Control #(ICR#): 17007640

Charge Description: On or about December 31, 2017, in the County of Rice, Minnesota, Antonio Levell Washington did confine or remove from one place to another, any person without the persons consent to commit great bodily harm or to terrorize the victim or another, to wit: CNW.

COUNT II

Charge: Tampering w/Witness-1st Deg-Prevent Testimony

Minnesota Statute: 609.498.1(a)

Maximum Sentence: 5 years and/or \$10,000 fine

Offense Level: Felony

Offense Date (on or about): 12/31/2017

Control #(ICR#): 17007640

Charge Description: On or about December 31, 2017, in the County of Rice, Minnesota, Antonio Levell Washington did by means of force or threats of injury to a person or property, intentionally attempted to prevent or dissuade a person who was to become a witness, from attending or testifying at a trial or proceeding authorized by law, to wit: C.N.W.

COUNT III

Charge: Domestic Abuse No Contact Order - Violate No Contact Order - Misdemeanor

Minnesota Statute: 629.75.2(b)

Maximum Sentence: 90 days and/or \$1,000 fine

Offense Level: Misdemeanor

Offense Date (on or about): 12/31/2017

Control #/(ICR#): 17007640

Charge Description: On or about December 31, 2017, in the County of Rice, Minnesota, Antonio Levell Washington did knowingly violate a domestic abuse no contact order.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about December 31, 2017, at approximately 9:18 p.m., Faribault Police officers were dispatched to 903 1st Avenue NW in Faribault for a 911 hand up call. This is located in Rice County. Dispatch stated that a female said to come to this address for a violation of a restraining order. The caller then hung up. Dispatch also advised that there were restraining order violations on prior contacts with the phone number of the caller which belonged to CNW, the protected party. The restrained party was Antonio Levell Washington, dob 07/02/1984, herein the Defendant. Officers responded to the address but did not find anyone at the residence.

At approximately 9:24 p.m., dispatch received another 911 call from CNW's phone number, stating that the Defendant was in a black truck in the Holiday Gas Station parking lot in Faribault. CNW said that she was at Holiday as well and was inside but had to go back out and hung up. Officers were unable to locate CNW, the Defendant or the truck at Holiday.

At approximately 9:30 p.m., dispatch advised officers that CNW was at HyVee, had locked herself in the bathroom, and the Defendant was outside in her vehicle in the parking lot. At 9:35 p.m., Officers located the Defendant at HyVee, located in the back seat of CNW's car. Officer Michael Shuda located CNW in the store. Officer Shuda spoke with CNW once in the store and several other times on the phone.

CNW reported that she has been staying at a shelter for the past few weeks because of repeated violations of an order for protection between the Defendant and CNW. CNW went to her house at 903 1st Avenue NW at approximately 9 p.m. to grab a few items before work. CNW left her car running to warm it up. When CNW came back out of the house, the Defendant walked up to her, told her he needed to get some things out of the house, and asked her for a key so that he could stay at the house.

CNW and the Defendant went inside the house, and the Defendant locked the door. The Defendant went through CNW's purse, took three \$100 bills and her driver's license, then told CNW to unlock her phone. Once the phone was unlocked, the Defendant went through her messages and got her phone number.

The Defendant then went through CNW's mail and found a subpoena for CNW to testify regarding a domestic assault that occurred between CNW and the Defendant. The Defendant told CNW, "you're going to get in there and you're going to say shit. You tell the kids not to say shit. You get in there and you shut the fuck up and say that none of this happened." CNW stated that the Defendant said that he had two women he beat on in the past when he was 22 years old. He "beat the shit out of her and she came to court and said I'm not testifying. I need you to get up there and do the same fucking thing." CNW told him that she would because she did not want him to hurt her. CNW said that now that the Defendant knows she is supposed to testify against him, he is going to hurt her.

CNW called 911 while at the house and continued calling 911 because she was hoping that she would be tracked by dispatch and officers could find her. The Defendant told Charlotte to get in the car and drive with the Defendant in the back seat. CNW complied because she was afraid that the Defendant would hurt her.

CNW did not think she could refuse without being hurt by the Defendant. CNW did not go with the Defendant of her own free will but out of fear of the Defendant.

CNW told the Defendant that she needed to get a drink from Holiday, stopped at Holiday, and called 911. When CNW and the Defendant left Holiday, the Defendant told CNW that she "would not make it to work tonight." CNW then drove to HyVee, telling the Defendant that she had a DVD she needed to return. Once CNW arrived, she went inside the store, call 911 and locked herself in the bathroom.

The Defendant told CNW, "Bitch, I have nothing to lose. I'm just going to go on the run." The Defendant has multiple cases pending in Rice County for violating Orders for Protection and Domestic Abuse No Contact Orders with CNW as the protected party.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
