Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Controlled Substance Crime in the 1st Degree (Sale) (Marijuana or Tetrahydrocannabinols) (25 or More Kilograms)**

Minnesota Statute: 152.021.1(6), with reference to: 152.021.3(a)

Maximum Sentence: 0-30 Years and/or \$300,000.00 - \$1,000,000.00

Offense Level: Felony

Offense Date (on or about): 02/02/2018 to 02/02/2018

Control #(ICR#): 18000375

Charge Description: On or about February 2, 2018, in the County of Dakota, Minnesota, AUSTIN JAMES HAGEN, did on one or more occasions within a 90-day period unlawfully sell one or more mixtures of a total weight of 25 kilograms or more containing marijuana or Tetrahydrocannabinols.

**COUNT II**

**Charge: Controlled Substance Crime in the 2nd Degree (Possession) (25 or More Kilograms of Marijuana or Tetrahydrocannabinols or 100 or More Marijuana Plants)**

Minnesota Statute: 152.022.2(a)(6), with reference to: 152.022.3(a)

Maximum Sentence: 0-25 Years and/or \$150,000.00 - \$500,000.00

Offense Level: Felony

Charge Description: On or about February 2, 2018, in the County of Dakota, Minnesota, AUSTIN JAMES HAGEN, did unlawfully possess one or more mixtures of a total weight of 25 kilograms or more containing marijuana or Tetrahydrocannabinols, or possessed 100 or more marijuana plants.

## STATEMENT OF PROBABLE CAUSE

On February 2, 2018, a police officer with the city of Lakeville stopped a motor vehicle for an equipment violation in the city of Lakeville, Dakota County, Minnesota. The driver of the vehicle was identified as Austin James Hagen, DOB 6/21/94. In talking with Hagen, the officer detected a odor of marijuana coming from inside the vehicle. The officer searched the vehicle and located a large duffel bag. Inside the duffel bag, were eight Tupperware containers. Inside each container, were a large number of candy-like edible “gummies”. There appeared to several thousand gummies in each container. A sample gummy was taken from each container a preliminarily tested using a Narcotics Identification Kit (NIK). Each sample tested positive for the presence of THC. The contents of each container was then weighed. The approximate net weight of the gummies inside the containers is in excess of 99 pounds (45 kilograms).

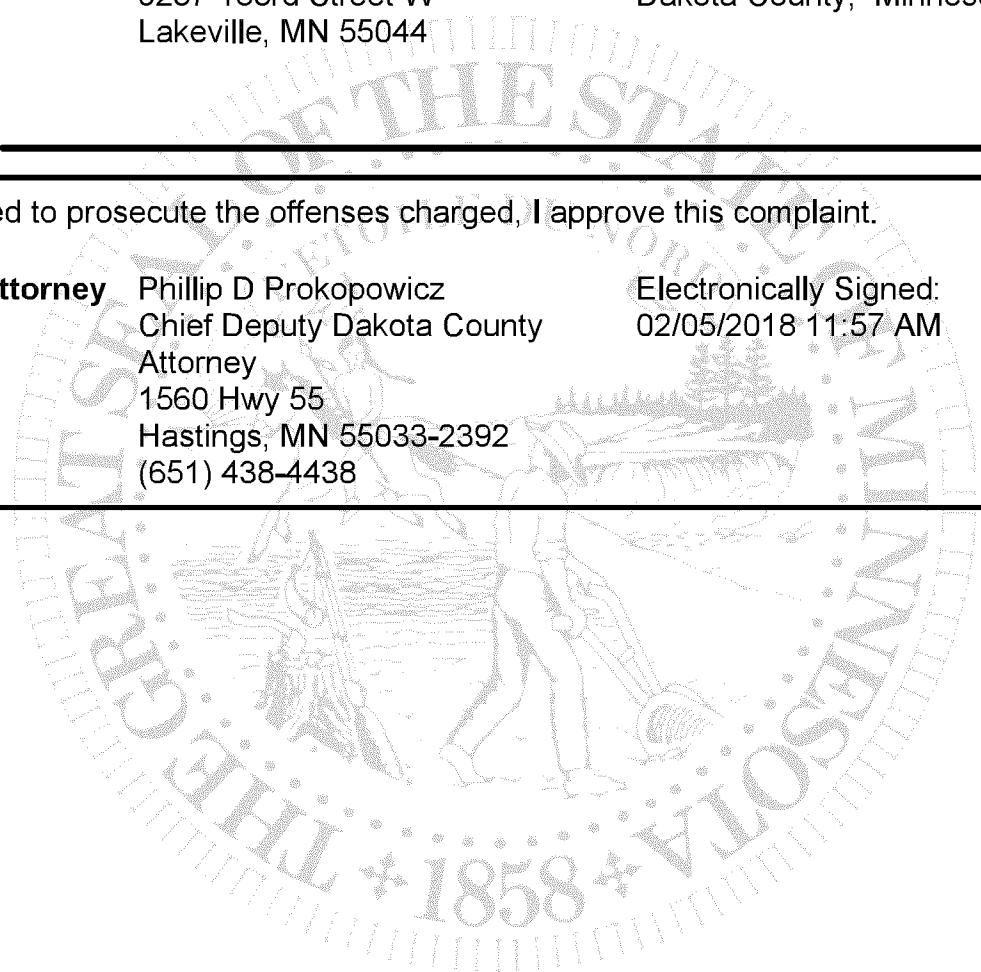
