The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction**

Minnesota Statute: 629.75.2(c)

Maximum Sentence: 10 days to 1 year or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Charge Description: On or about March 17, 2018, in the County of Rice, Minnesota, Timothy Steven Schaefer did knowingly violate a domestic abuse no contact order within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency, to wit: C.A.S.

**COUNT II**

**Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction**

Charge Description: On or about March 17, 2018, in the County of Rice, Minnesota, Timothy Steven Schaefer did knowingly violate a domestic abuse no contact order within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency, to wit: C.T.S.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On March 17, 2018, at approximately 10:38 p.m., officers were dispatched to 488 Southbridge Drive, Northfield, Rice County, on reports of a possible domestic assault. Officers arrived on scene and attempted to make contact with the occupants. Officer Feldhake looked through the lower window in the kitchen and observed Timothy Steven Schaefer (DOB: 03/02/1982) and C.A.S. (DOB: 07/05/1977). Officer Feldhake has had contact with Schaefer and C.A.S. in the past. Schaefer and C.A.S. were yelling loud enough at one another that they could be heard outside of the residence. While Officer Feldhake was observing Schaefer and C.A.S., other responding officers were knocking at the front door. Officer Feldhake then observed both Schaefer and C.A.S. walk towards the front door. C.A.S. then pointed for Schaefer to go upstairs. Schaefer then grabbed a beer and walked upstairs.

A search warrant for the residence was drafted and signed. C.A.S. finally responded to the front door, but refused to open it despite being informed that the officers had a search warrant. The officers forced entry into the residence and located Schaefer hiding in an upstairs bedroom. C.A.S. was also located inside of the residence along with her minor child, C.S. (born 2012).

There is an active Domestic Abuse No Contact Order (DANCO) in Court File No. 66-CR-18-2, which restrains Schaefer from having contact with C.A.S. and C.S. The DANCO also restrains Schaefer from going to 488 Southbridge Drive, Northfield, MN, 55057. Schaefer was personally served with the DANCO on January 2, 2018.

Schaefer has a previous qualified domestic-related violence conviction from April 10, 2013 (Court File No. 66-CR-13-181), which is being used to enhance the current charges.

**PLEASE TAKE NOTICE:** Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
