The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Escape From Custody - Held Pursuant to Lawful Arrest

Minnesota Statute: 609.485.2(1), with reference to: 609.485.4(a)(1)

Maximum Sentence: Not more than 5 years in prison, a \$10,000 fine, or both.

Offense Level: Felony

Offense Date (on or about): 04/09/2018

Control #(ICR#): 18000396

Charge Description: On or about April 6, 2018, in Rice County, Minnesota, Casey Daniel Bauer, the defendant, escaped while held in lawful custody on a conviction of a felony.

STATEMENT OF PROBABLE CAUSE

The C	Complainan	t states that	the following	facts establish	n probable cause:	

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On March 12, 2018, CASEY DANIEL BAUER (date of birth, 10/18/1990, the defendant), was the defendant in a Jury Trial, Rice County District Court file number 66-CR-16-152. The defendant was charged with three counts, including: Assault in the Second Degree – Dangerous Weapon – Substantial Bodily Harm; Assault in the Third Degree – Substantial Bodily Harm; and Threats of Violence. On March 16, 2018, the jury returned verdicts of guilty for Counts 1 and 2. The jury returned a verdict of not guilty for Count 3.

After the verdict was read, the Honorable John T. Cajacob ordered the defendant held in custody until sentencing, set for May 23, 2018. No bail or other conditions of release were set. The defendant was held at the Rice County Jail, Faribault, MN in Rice County.

On March 29, 2018, the defendant wrote a letter to Judge Cajacob requesting permission to visit the defendant's mother due to her cancer. The defendant wrote, "I have just received news that my moms cancer has spread to her brain since I've been here ... I want to see my mom before she dies. ... I'm not a flight risk. I know you've heard it all before but I will come back whenever you want me to and be very grateful."

On April 2, 2018, Judge Cajacob granted the defendant a 72-hour furlough for the defendant to go see his mother.

On April 3, 2018, Rice County Jail staff prepared a Furlough form and met with the defendant. The form stated the defendant would be released on April 3, 2018, at 10:30 a.m.; the defendant was to return no later than April 6, 2018, at 10:30 a.m. The defendant signed the form. The defendant was later processed by jail staff, who again told the defendant he was to return April 6, 2018 at 10:30 a.m.

On April 6, 2018, the defendant did not return to the Rice County Jail; his whereabouts were listed as unknown. A warrant was issued for the defendant's arrest.

On April 13, 2018, the defendant was arrested by the Dakota County Sheriff's Office. The defendant was returned to the Rice County Jail.

According to Minn. Stat. 609.485, Subd. 1, Definitions, "Escape" includes departure without lawful authority and failure to return to custody following temporary leave granted for a specific purpose or limited period.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
