The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 1st Degree - Sale - 17 Grams or More-Cocaine or Meth w/in 90-Day Period

Minnesota Statute: 152.021.1(1), with reference to: 152.021.3(a)

Maximum Sentence: up to 30 years prison, or \$1,000,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/09/2018

Control #(ICR#): 18000181

Charge Description: On or about May 9, 2018, in Rice County, Minnesota, Heather Anderson Larscheid did unlawfully sell, or possess with the intent to sell, give away, barter, deliver, exchange, distribute, or dispose of to another, one or more mixtures containing methamphetamine with a weight of 17 grams or more.

COUNT II

Charge: Drugs - 3rd Degree - Possess 10 grams or more a narcotic drug other than heroin

Minnesota Statute: 152.023.2(a)(1), with reference to: 152.023.3(a)

Maximum Sentence: up to 20 years prison, or \$250,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/09/2018

Control #(ICR#): 18000181

Charge Description: On or about May 9, 2018, in Rice County, Minnesota, Heather Anderson Larscheid did unlawfully possess one or more mixtures containing a schedule II narcotic, to wit: methamphetamine, with a total weight of 10 grams or more.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about May 9, 2018, an officer with the Lonsdale Police Department was on patrol in the City of Lonsdale. The officer saw a truck fail to stop at the stop sign at Gonvick Ave and Union Lake Trail. The truck then failed to signal a right hand turn on Halstad Ave. The officer followed the truck and observed the truck over the center line at Halstad Ave and Bluff Heights Drive. At this time, the officer conducted a traffic stop on the vehicle.

When approaching the vehicle, the officer observed a male driver and male passenger. The officer spoke with the male driver. The male driver stated his license was not current and that it was suspended. The driver stated he did not have his ID but gave his name and date of birth. The officer confirmed the driver had a suspended license and placed the driver under arrest.

After placing the driver in custody, the officer was advised by another officer that there was a female trying to lay down in the back seat of the truck and not wearing a seat belt. It appeared as if the female was trying to remain hidden. When the officer returned to the open driver's door of the truck, the officer observed a metal pipe and blow torch sitting on the seat in plain view. The officer then recognized the male passenger as Samuel David Bice, DOB: 06/24/1979 (hereinafter the male defendant). The officer asked the male defendant for the name of the female trying to hide herself in the back seat of the truck. The female then sat up right away and said her name was Heather. The officer asked the female what her last name was and she stated that was not important at this time. The officer then shined his flashlight in the cab of the truck and recognized the female as Heather Anne Anderson Larscheid, DOB: 10/17/1979 (hereinafter the female defendant). Dispatch confirmed the female defendant had multiple active warrants in four separate counties and she was placed under arrest.

Two of the female defendant's active warrants were for two separate Rice County cases. Each case involving possession of methamphetamine. One of the cases alleges introduction of methamphetamine into the jail. In each case, and on separate dates, the defendant failed to appear for a default omnibus hearing as well as a contested omnibus hearing.

After placing the female defendant into custody, the officers returned to the truck and spoke with the male defendant still in the passenger seat. The officer asked if there was anything in the vehicle like drugs, or guns. The male defendant initially just lowered his head. The male defendant eventually stated there was a

pipe in his pocket. The officer asked if it was just a pipe and the male defendant stated it was not just a pipe, it was full of residue. The officer asked if it was marijuana residue and the male defendant stated no it is meth. The male defendant then removed the pipe and handed the pipe to the officer. The male defendant was placed under arrest for the pipe with methamphetamine residue.

The officers then returned to the vehicle to conduct a full search. During the search of the area where the female defendant was found, the officer located a green purse. Inside of the purse was a silver container that contained ten (10) new hypodermic needles and two bags of a clear rock substance that tested positive for methamphetamine. The methamphetamine weighed 23.1 grams. There was also a small container of empty baggies and \$83.00 in cash. Alongside the green purse was a silver in color bag that contained a multiple color small zipper bag that contained 3 glass containers with a cotton substance that was wet. This substance also tested positive for methamphetamine. There was also a Nitro scale. Also inside the Silver Bag was a black box that contained a clear plastic tube and mouthpiece that had methamphetamine residue.

The other officer located a backpack in the back seat. In the front pocket of the backpack the officer located a "Blade" scale. In the side pocket of the backpack the officer located an "AWS" scale.

The amount of methamphetamine found in the female defendant's possession is indicative of sale or distribution. Quantities of methamphetamine over 3.5 grams typically indicate sale or distribution and in this case there was 23.1 grams. The presence of gram level scales in proximity to large quantities of controlled substances is indicative of sale or distribution. In this case officers located three different scales in the back seat of the truck where the meth was found. Multiple new hypodermic needles and multiple new plastic baggies in proximity to large quantities of controlled substances is indicative of sale or distribution. In this case there were 10 new needles and a package of baggies. Based on the quantity of methamphetamine, the presence of multiple scales, the presence of multiple unused baggies, and the presence of multiple new hypodermic needles, the defendant possessed the 23.1 grams of methamphetamine with the intent to sell or distribute.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
