COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Traffic - First Degree DWI - Operate Motor Vehicle Under Influence of Alcohol

Minnesota Statute: 169A.20.1(1), with reference to: 169A.24.2

Maximum Sentence: 7 years and/or \$14,000 fine

Offense Level: Felony

Offense Date (on or about): 05/03/2018

Control #(ICR#): 18001784

Charge Description: On or about May 3, 2018, in Rice County, Minnesota, Corey Allen Jablinske, the defendant, did drive, operate or be in physical control of a motor vehicle when under the influence of alcohol, and having previously been convicted of First Degree DWI (felony).

COUNT II

Charge: Traffic -First Degree DWI - Refuse to Submit to Chemical Test Crime

Minnesota Statute: 169A.20.2(1), with reference to: 169A.24.2

Maximum Sentence: 7 years and/or \$14,000 fine

Offense Level: Felony

Offense Date (on or about): 05/03/2018

Control #(ICR#): 18001784

Charge Description: On or about May 3, 2018, in Rice County, Minnesota, Corey Allen Jablinske, the defendant, did refuse to submit to a chemical test of breath pursuant to sections 169A.51 or 169A.52, after having driven, operated or been in in physical control of a motor vehicle and having previously been convicted of a First Degree DWI (felony).

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On May 3, 2018, at 5:57 p.m., Faribault Police Officer Thul was dispatched to 829 Prairie Avenue, Faribault, Rice County, Minnesota, on a report of a male who was slumped inside a vehicle that was partially parked in a driveway. The vehicle was parked diagonally across the side of the house. The front tires were off the driveway and were in the landscaping. It appeared that the vehicle had been trying to back out of the driveway. The vehicle had MN license plate no. 482MLP. Officer Thul arrived on the scene and saw a male who was partially slumped over in the driver's seat of the vehicle. An EMT told Officer Thul that the male was unconscious when she arrived. The male did not wake up until she opened the door. Officer Thul saw the keys on the passenger seat next to the male's phone.

The male was identified as COREY ALLEN JABLINSKE, date of birth 9/11/1986, the defendant herein. Officer Thul recognized the defendant from prior contacts. Officer Thul was aware that the defendant was on parole for First Degree DWI. The defendant said he was trying to move the vehicle. The defendant's speech was very slurred. The defendant's motor movements were very slow. The defendant denied that he had been drinking. The officer could detect a strong odor of a used alcoholic beverage coming from the vehicle. The officer asked the defendant to exit the vehicle.

The defendant almost fell as he got out of the vehicle. He needed the assistance of the officer to prevent him from falling. The defendant tried to stand but was staggering and swaying a lot. He could not stand without the officer's assistance. The defendant said the vehicle was his even though it was registered to his girlfriend. The defendant declined to submit to a PBT. The defendant was placed under arrest for DWI. The defendant was transported to the Rice County Jail.

At 6:22 p.m., Officer Thul read the Breath Test Advisory to the defendant. The defendant requested to speak to an attorney. The defendant declined to take the breath test. He said the attorney told him not to.

The defendant refused to submit to a PBT at the jail. The defendant was transported to a detox facility in Rochester.

The defendant's girlfriend said she knew the defendant to be "extremely intoxicated." He is not supposed to be driving the vehicle. The defendant had been drinking at work. The defendant got home around 6:00 a.m. The defendant continued to drink more throughout the day. She spoke to him by phone and could hardly understand him.

The defendant has the following prior felony DWI conviction:

On January 11, 2010, the defendant was convicted of First Degree DWI (Felony) in Clay County District Court File No. 14-CR-09-3731.
