The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 2nd Degree - Sale 3 grams or more - Heroin w/in 90-day period**

Minnesota Statute: 152.022.1(3), with reference to: 152.022.3(a), 152.01.15a

Maximum Sentence: 25 years or \$500,000, or both

Offense Level: Felony

Offense Date (on or about): 05/31/2018 to 06/07/2018

Control #(ICR#): 18002283

Charge Description: On or between May 31, 2018 and June 7, 2018, in Rice County, Minnesota, Scott Hargenrader did unlawfully sell, within a 90 day period, one or more mixtures containing heroin with a total weight of 3 grams or more.

## STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

During the months of May 2018 and June 2018, the Cannon River Drug and Violent Offender Task Force and the South Central Drug Investigation Unit conducted a joint investigation into the primary supplier of heroin into Rice County. The investigation identified Anthony Michael Fugalli, DOB 10/29/1990 as the main source of heroin. The joint investigation resulted in four heroin sales by Fugalli to a Confidential Informant (CI). Two of the sales were facilitated by Fugalli, however a runner was sent to complete the sales. Those two sales were directly conducted by Scott Anthony Hargenrader, DOB: 09/09/1989.

On May 31, 2018, the CI informed agents that the CI could buy 3 grams of heroin from Fugalli. The total for the transaction would be \$650. The CI was dropped off at Hy-Vee in the City of Faribault to meet with Fugalli. Approximately 15 minutes after being dropped off, the CI was picked up by a male party driving a 2017 Ford Focus. Agents were able to identify the male as Hargenrader. The CI and Hargenrader left Hy-Vee in the vehicle. During the drive, the CI handed \$650 to Hargenrader. Hargenrader then handed the CI the 3 grams of heroin. Approximately four minutes later, the CI was dropped off at Walmart by Hargenrader. Agents then followed Hargenrader as he left Walmart. Hargenrader went to Burger King in Faribault and met up with Fugalli.

The heroin subsequently weighed 3.2 grams with packaging.

On June 7, 2018, the CI informed agents that the CI could buy 3 more grams of heroin from Fugalli. The total for this transaction would be \$510. The CI was again dropped off at Hy-Vee in the City of Faribault to meet with Fugalli. While waiting for Fugalli, the CI was texting with Fugalli. Fugalli informed the CI that Hargenrader would be meeting the CI. Approximately 15 minutes after being dropped off, the CI was again picked up by Hargenrader. The CI and Hargenrader left Hy-Vee in the vehicle, which was the same vehicle from the first sale. During the drive, the CI handed \$510 to Hargenrader. Hargenrader then handed the CI the 3 grams of heroin. Approximately three minutes later, the CI was dropped off at Walmart by Hargenrader. Agents again followed Hargenrader as he left Walmart. Again, Hargenrader went to Burger King in Faribault and met up with Fugalli.

The heroin subsequently weighed 2.8 grams.

On June 12, 2018, the CI informed agents that the CI could buy another 3 grams of heroin from Fugalli. The total for this transaction would be \$510. The CI was again dropped off at Hy-Vee in the City of Faribault to meet with Fugalli. Approximately three minutes after being dropped off, the CI was picked up by Fugalli in a 1999 Ford Escort. The CI and Fugalli left Hy-Vee in the vehicle. During the drive, the CI handed \$510 to Fugalli. Fugalli then handed the CI the 3 grams of heroin. Approximately four minutes later, the CI was dropped off at Walmart by Fugalli.

The heroin subsequently weighed 2.8 grams.

On June 19, 2018, the CI informed agents that the CI could buy 4 grams of heroin from Fugalli. The total for this transaction would be \$750. The CI was again dropped off at Hy-Vee in the City of Faribault to meet with Fugalli. Approximately five minutes after the CI was dropped off, Fugalli arrived at the Hy-Vee in the same 1999 Ford Escort. Along with Fugalli was an unknown male and two female parties. Fugalli and the three other people entered Hy-Vee. They then left Hy-Vee. A short time later, Fugalli returned to the Hy-Vee alone, again in the 1999 Ford Escort. The CI was picked up by Fugalli. The CI and Fugalli left Hy-Vee in the vehicle. During the drive, the CI handed \$750 to Fugalli. Fugalli handed the CI the 4 grams of heroin. Approximately three minutes later, the CI was dropped off at Walmart by Fugalli.

The heroin subsequently weighed 4.1 grams.

Fugalli offered or agreed to sell a total of 13 grams of heroin to the CI. Hargenrader directly sold approximately 6 grams of heroin to the CI. Fugalli directly or indirectly sold approximately 12.9 grams of heroin to the CI.

Fugalli was previously arrested on April 9, 2018 for 2<sup>nd</sup> Degree Sale of heroin. Fugalli was subsequently charged with 2<sup>nd</sup> Degree Sale of heroin. Fugalli posted \$50,000 bond with conditions which included no possession of controlled substances and to remain law abiding.

Following Fugalli's arrest, a post *Miranda* interview was conducted. During the interview, Fugalli provided numerous incriminating admissions. Fugalli admitted that he has been selling heroin. Fugalli admitted that his heroin is cut with fentanyl. Fugalli admitted that he knew Fentanyl could cause death. Fugalli admitted that his dope was strong. Fugalli admitted he was warning his customers that his heroin was strong. As to the four specific buys in this case, Fugalli admitted to selling heroin to the CI. Fugalli admitted that he used Hargenrader as a runner for some of the buys. Fugalli admitted that his heroin even caused him to doze off.

**PLEASE TAKE NOTICE:** Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
