The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Felony 5th Degree Controlled Substance- Possess Schedule 1,2,3,4

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years and/or \$10,000 fine

Offense Level: Felony

Offense Date (on or about): 07/24/2018

Control #(ICR#): 18000162

Charge Description: On or about July 24, 2018, in Rice County, Minnesota, William Ryan Daniel Sullivan did unlawfully possess one or more mixtures containing a schedule I hallucinogen in an amount greater than .25 grams.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Complainant and/or Signing Officer designated below, declares under penalty of perjury, that he/she has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On or about July 24, 2018, an officer with the Dundas Police Department was on patrol in the City of Dundas. The officer ran the license plate of a moving vehicle and found the registered owner to be revoked. The officer turned around to catch the vehicle and found it parked on the side of the road. The officer made contact with the driver of the vehicle, identified as William Ryan Daniel Sullivan, DOB: 05/16/2000 (hereinafter the defendant). There was also a juvenile male passenger in the vehicle. While talking with the defendant, the officer noticed a smell of marijuana coming from the vehicle. The defendant told the officer there had been marijuana in the vehicle about 5 hours ago.

A search of the vehicle was conducted. The officer found a baggie of mushrooms in the driver side door. The defendant admitted the bag in the driver's side door was mushrooms.

Numerous other items were found in the vehicle. There were numerous glass smoking pipes with marijuana residue, a scale with marijuana residue, and a rolled up dollar bill in the center console with a white residue on it. In a bag, officers found marijuana, a baggie containing a crystal substance that tested positive for methamphetamine. Also in the bag were two other baggies, one with a brown substance that the passenger admitted was DMT.

The mushrooms appeared to be Psilocybin mushrooms which contain a schedule I hallucinogen. The weight of the mushrooms without the baggie was over .25 grams.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
