The Northfield City Council considers a motion to approve the scope, project and focus area for the Northfield Transportation Advisory Committee to include the following: Highway 246 Turnback (including additional review of improvements to the road including, but not limited to, a pedestrian underpass or overpass crossing for Jefferson Parkway); Rail Transport (freight, passenger, train noise), Transit (intra-City and inter-city), Transit Hub, and Highway 19 corridor related initiatives.

Upon further review, the rail transport is a longer term prospect to review and nothing immediately urgent related to projects. Regarding train noise, staff is gathering information for the next council budget discussion on November 13th or 20th to potentially include some funding or discussion in this area and additional background on train noise. The Transit Hub has been a project supported by council and requested to be included on this agenda item so it was added. The transit was clarified to include both transit within the city but also connecting to other communities.

4. <u>18-480</u> Presentation Recognizing KYMN Radio's 50th Anniversary.

Councilor Ness recognized KYMN Radio for 50 years on the air. Ness presented a certificate to KYMN representatives in recognition of their 50th anniversary. Wayne Eddy thanked the Council for the recognition.

5. <u>18-481</u> Presentation on Recognizing the Second Monday in October as Indigenous Peoples Day in Northfield, Minnesota.

City Administrator Martig introduced this item. HRC representatives Mar Valdecantos and Angelique Dietz provided information on recognizing the second Monday of October as Indigenous Peoples Day in Northfield. Angelique Dietz read a statement prepared by the Human Rights Commission.

6. <u>18-482</u> Presentation of September 20 Tornado and Thunderstorm Response Update.

Public Works Director/City Engineer Bennett spoke regarding the clean up effort and progress. Noted staff is moving to parks cleanup at this time. The neighborhood pickup will start on October 8 to allow residents time to get debris to the curb for pickup. Bennett noted they are not observing a lot of debris in the boulevard at this time. The City will be going back to grind stumps in the right of way after the other tasks are completed. Will be reopening the compost site later this week. Information will be posted on the website. Interim Community Development Director Ericson provided information on the survey of home damage. Noted mostly minor storm damage to homes in the southeast area of the community. Ericson reported on the door-to-door efforts in this area regarding damage assessment and finding out if people needed help cleaning up. Ericson Introduced Mike Krance, Northfield Shares and the volunteers that assisted Rachel & Naomi Neesler, Steph Helkenn from Rejoice Church. Krance noted part of Northfield Shares mission is inspiring volunteer efforts. Northfield Shares works as more of connector. 50 people reached out to Northfield Shares wanting to get involved with storm cleanup efforts. Northfield Shares worked to connect volunteers with people in need. Naomi & Rachel developed a Google form to facilitate this effort. They shared their story on how they got involved. Steph Helkenn talked about reaching out to other churches in town and sending over 200 volunteers out. She noted they are committed to the long haul and are about serving the community and building connections. Krance noted they have joined Crisis Cleanup, a platform to list properties in need of assistance. Groups can claim a property and come and assist with efforts. Noted a group from Brainerd came and assisted over the weekend. Over 75 properties have been entered into Crisis Cleanup. About half have been taken care of already. Moving forward, Northfield Shares will continue to gather information and put into Crisis Cleanup and looking at cleanup weekends. The major need is for people that can haul things, pickups, trailers and people with chain saws. Noted there are sports teams willing to walk fields if farms are needing people. Also noted there are many efforts going on that we aren't aware of. City Administrator Martig thanked staff and volunteers involved. Mayor & Council thanked those involved.

Patrick Tomczik, 1203 Woodland Trail, spoke regarding levy and information contained in the City water bill. Tomzcik asked who paid for the information contained in water bill, how much will it cost taxpayers and why the City is paying for a private business. Mayor Pownell noted rules of business and asked Tomzcik to submit questions in writing for a response.

Larry DeBoer, 1405 Mayflower Drive, noted he spoke in June when the referendum came up. He stated nothing was said at the meeting about an excise tax, asked when the

language was approved, and asked about transparency. He stated he cannot find the information about when it was approved. Mayor Pownell offered to meet with both Mr. DeBoer and Mr. Tomczik.

Dorothea Hrossowyc, rural Northfield, thanked Council for designating Indigenous Peoples Day and spoke regarding her view of the importance of the alternative view.

Bob Kell, 806 Spring Str. S., spoke regarding designating Indigenous Peoples Day. Noted family heritage and that he has been a citizen of Northfield for 25 years. Stated it is important to respect the rights of all people.

Mar Valdecantos, HRC Chair, thanked Council for passing designation of Indigenous Peoples Day. Spoke about next steps.

Olivia Frey, 401 Highland Ave., read a statement regarding celebrating Indigenous Peoples Day. Noted Northfield Reads film showing on October 28 at Weitz Center.

CITY OF NORTHFIELD, MINNESOTA **CITY COUNCIL RESOLUTION 2018-098**

RECOGNIZING THE SECOND MONDAY OF OCTOBER AS INDIGENOUS PEOPLES DAY

- WHEREAS, the City of Northfield was established in 1856, after Indigenous Dakota and Ojibwe Peoples of the region were forcibly removed from the lands upon which they had lived since time immemorial; and
- WHEREAS, the United States federal government, the State of Minnesota, and the City of Northfield recognize Columbus Day on the second Monday of October, in accordance with the federal holiday established in 1937.
- WHEREAS, the idea of Indigenous Peoples Day was first proposed in 1977 by a delegation of Native nations to the United Nations sponsored International Conference on Discrimination Against Indigenous Populations in the Americas; and
- WHEREAS, in 1990 representatives from 120 Indigenous nations at the First Continental Conference on 500 Years of Indian Resistance unanimously passed a resolution to transform Columbus Day into an occasion to strengthen the process of continental unity and struggle towards liberation, and thereby use the occasion to reveal a more accurate historical record.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL THAT:

- 1. The City Council that the City of Northfield shall recognize Indigenous Peoples Day in addition to Columbus Day on the second Monday in October annually hereafter.
- 2. The City of Northfield encourages businesses, organizations and public entities to recognize Indigenous Peoples Day on the second Monday of October, and "seek to promote practices and policies that honor the state's Indigenous roots, history, and contributions and reflect the experiences of Indigenous Peoples to insure greater access and opportunity". (Governor Dayton's Indigenous Peoples Day Proclamation, October 2016).
- 3. That Indigenous Peoples Day shall be used to reflect upon the history of how Indigenous Peoples have been treated over time, to celebrate the contributions to the thought and culture of the region made by Dakota, Ojibwe, and other Indigenous nations, and to consider the ongoing struggles and sacrifices of Indigenous people on this land.

Area Map of the Clinton Heights Second Addition


















Greenvale Park Elementary School Walking Area/Issues Map

Safe Routes to School Northfield, MN


